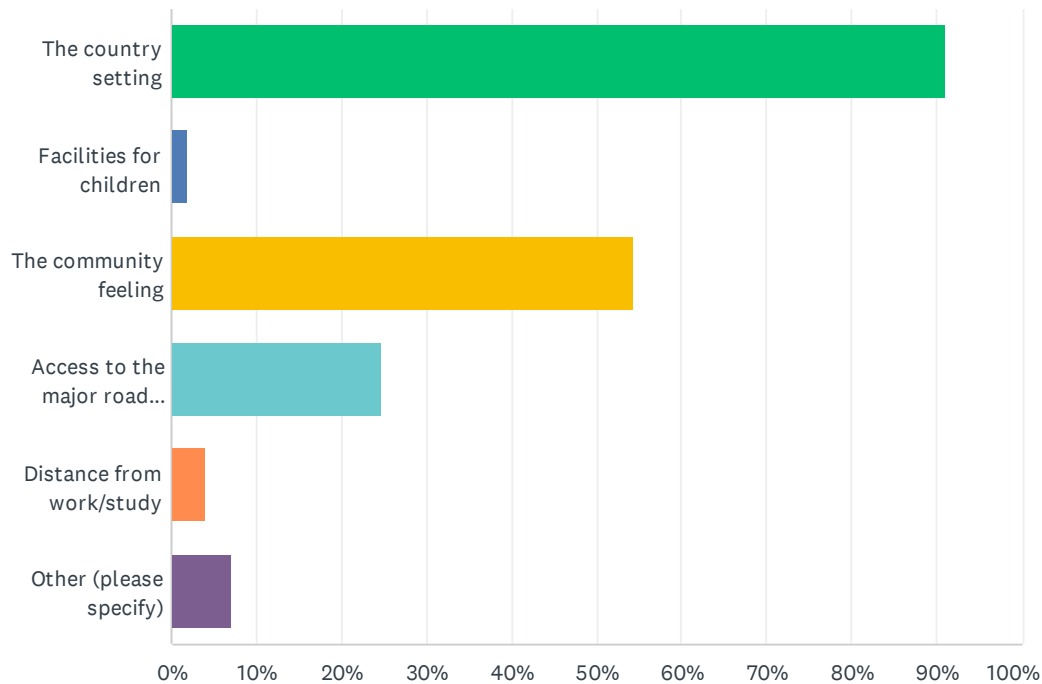

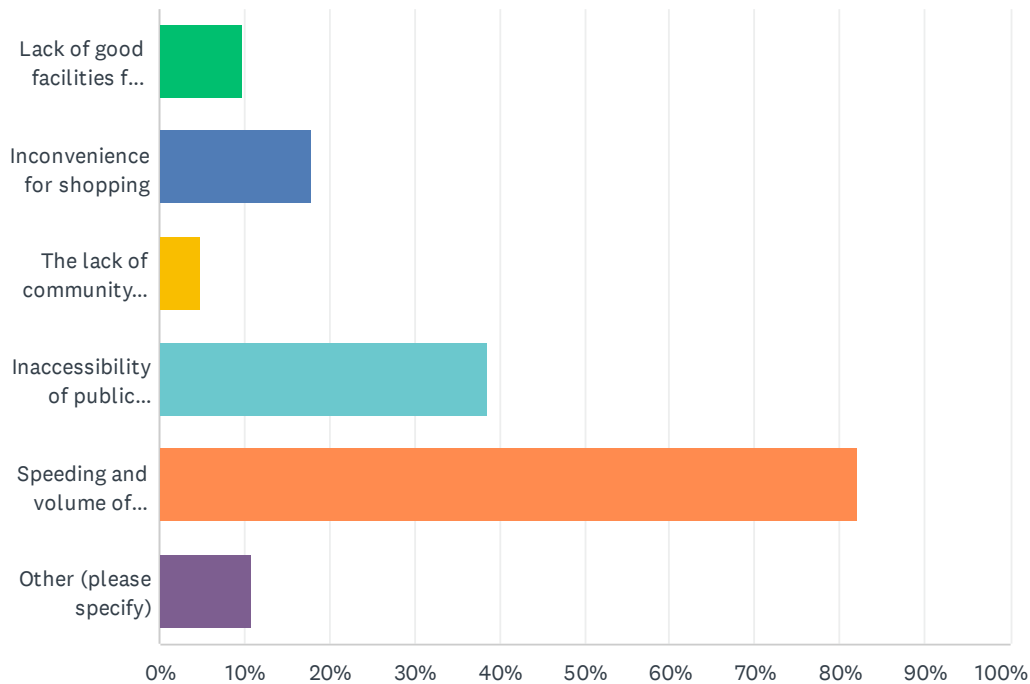

Q2 What do you dislike most about the Parish?

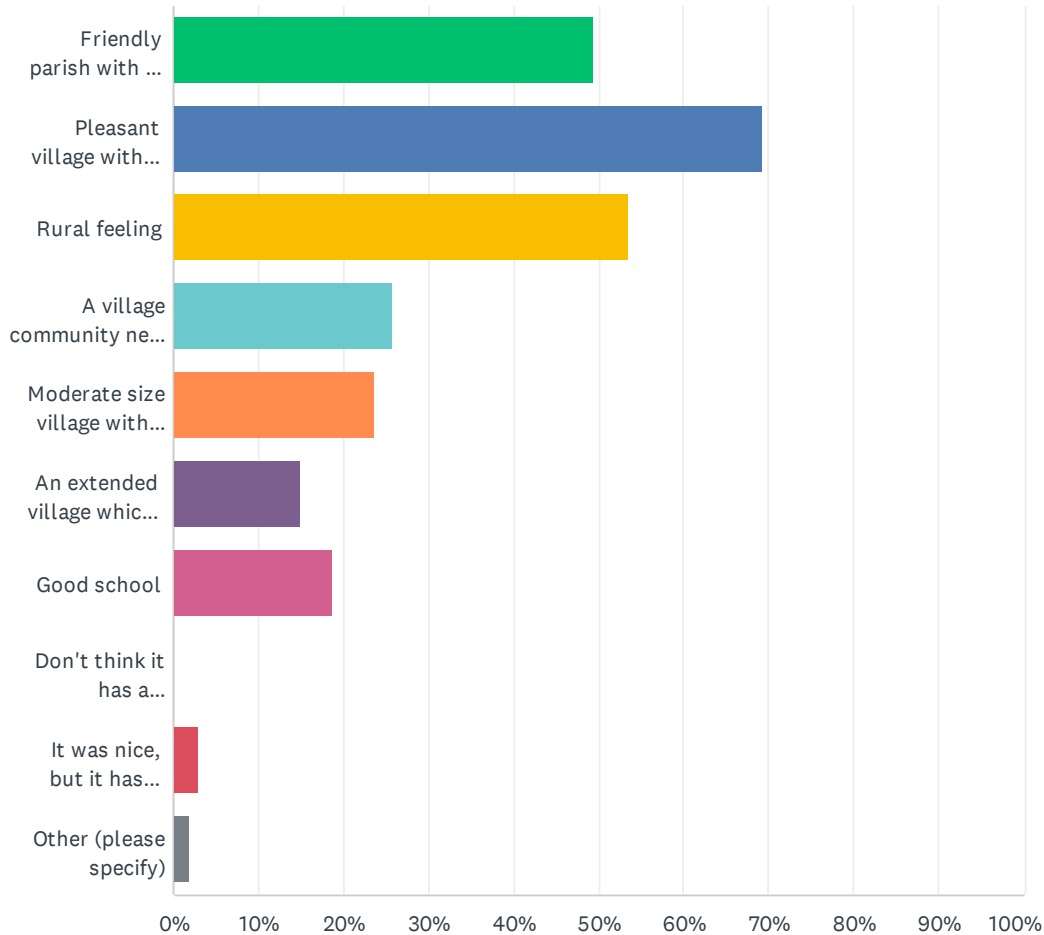

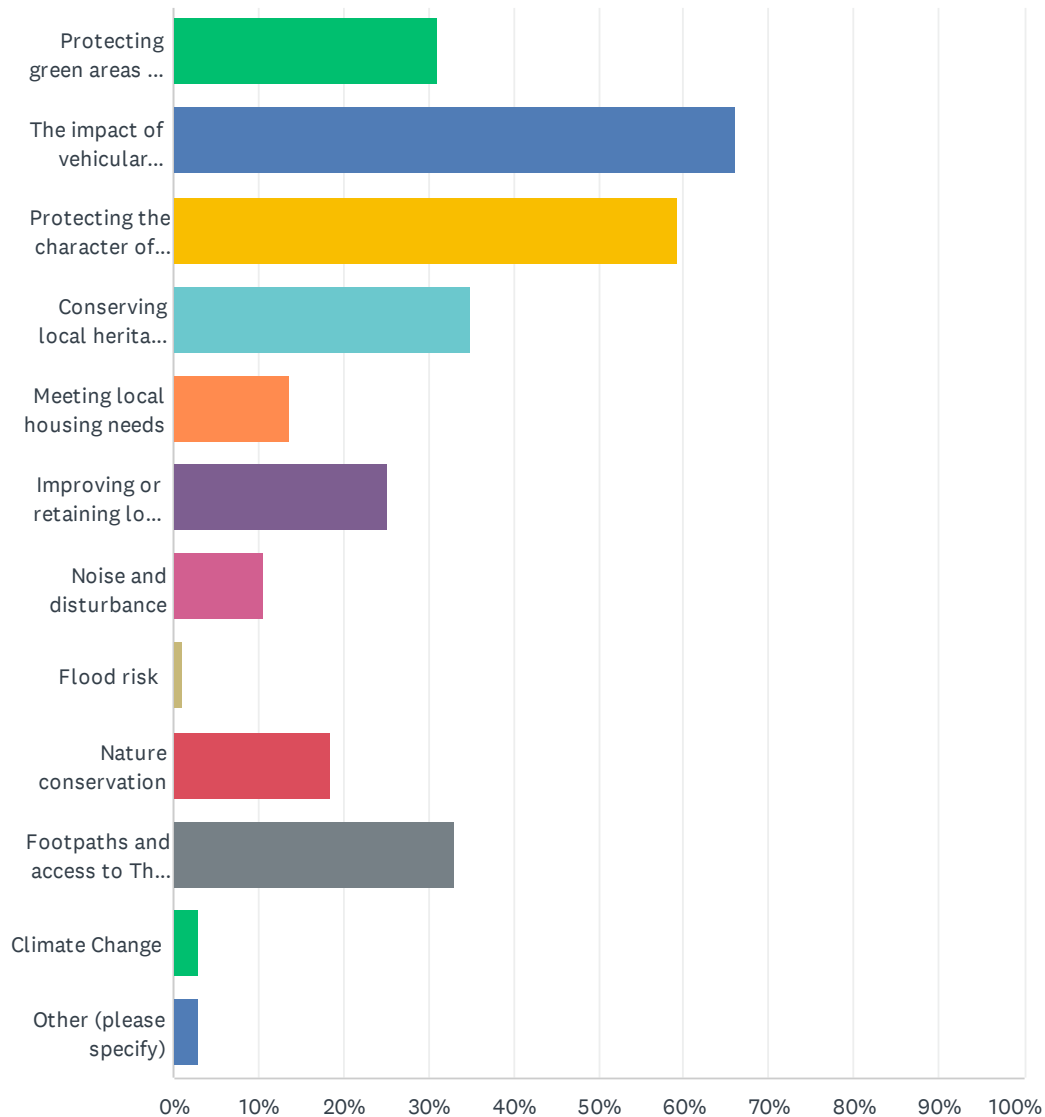

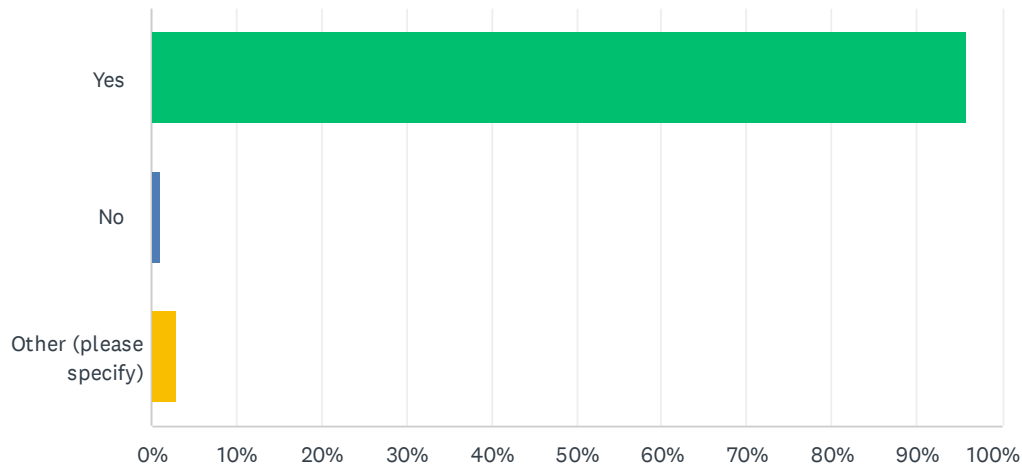

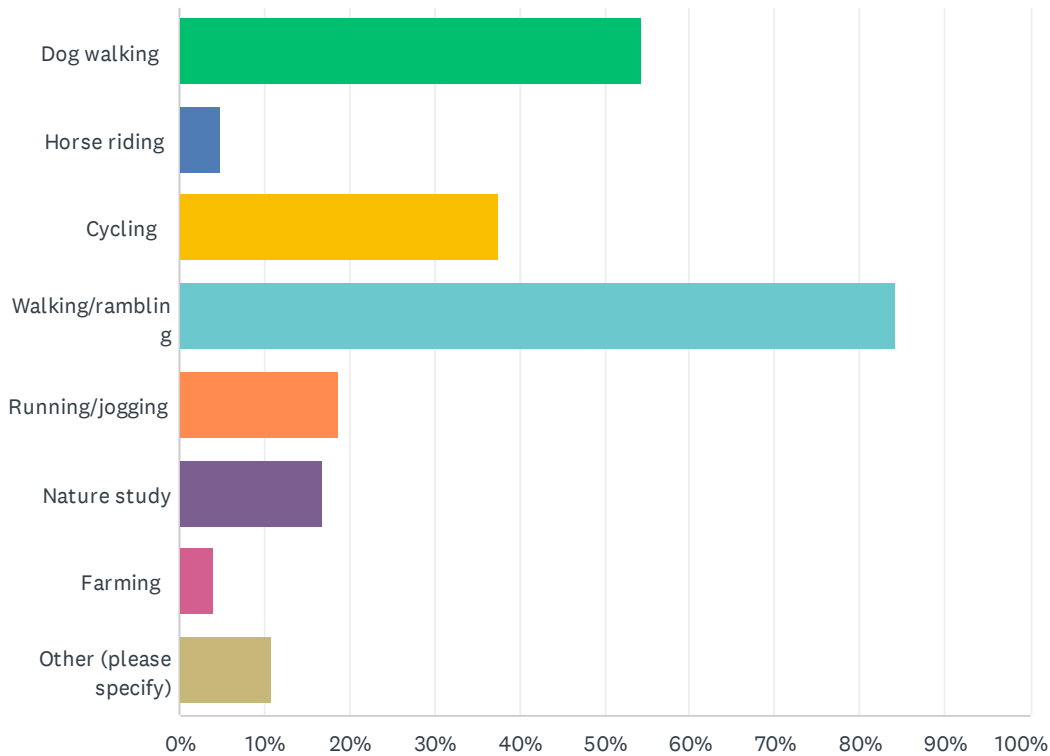

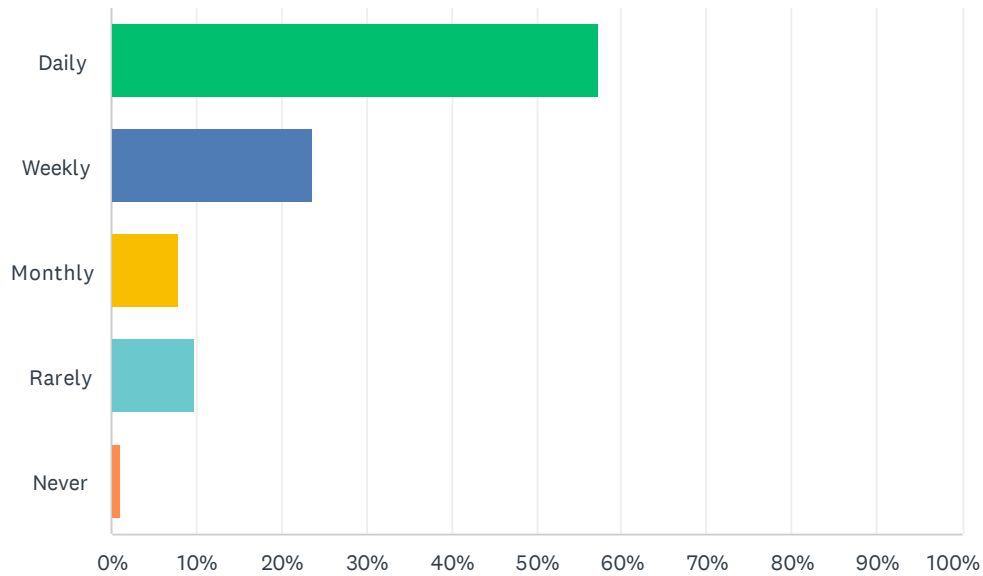

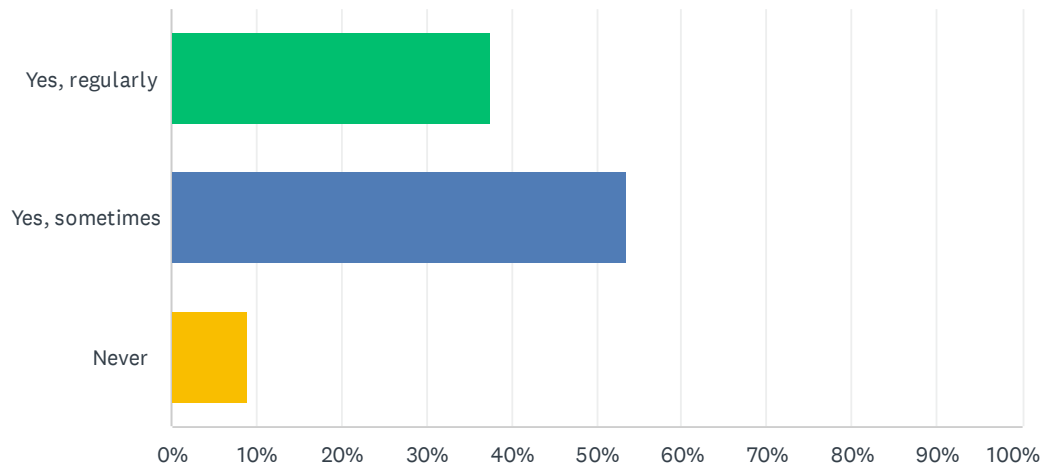

Q8 Do you ever use The Greenway?

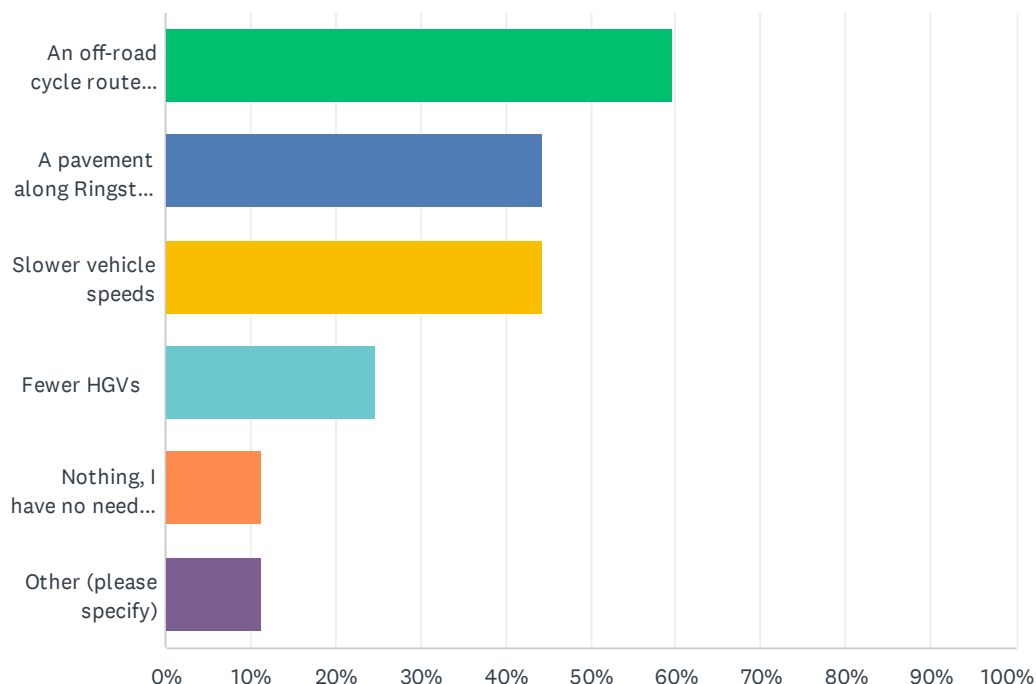

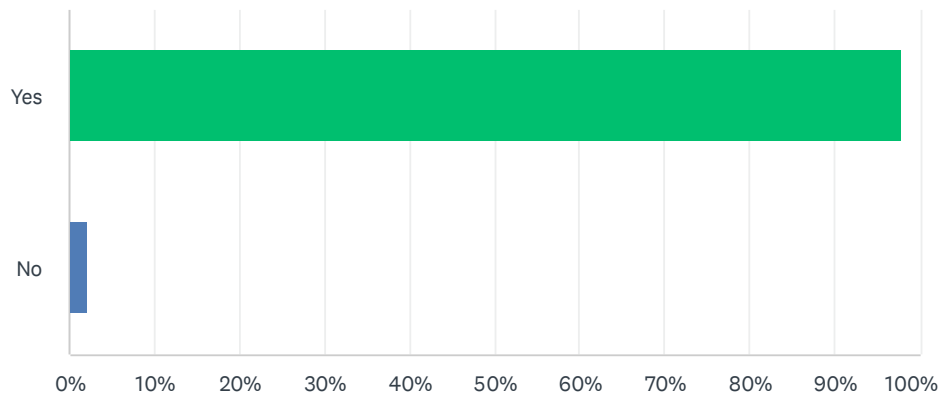

Q14 Do you have concerns about light pollution in your locality?

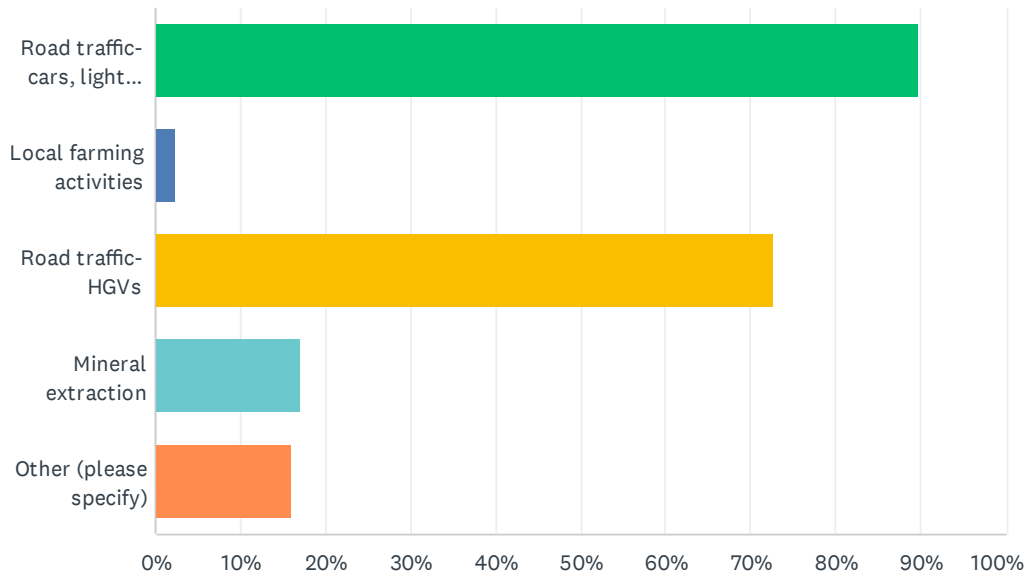

Q15 Do you have concerns about noise and/or disturbance from the following? (Please select all those that apply)

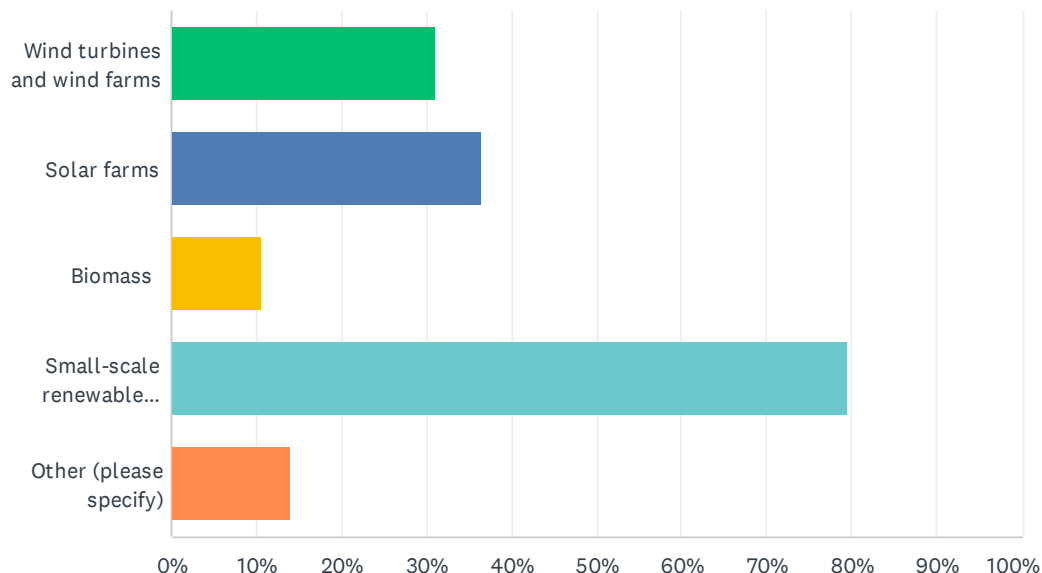

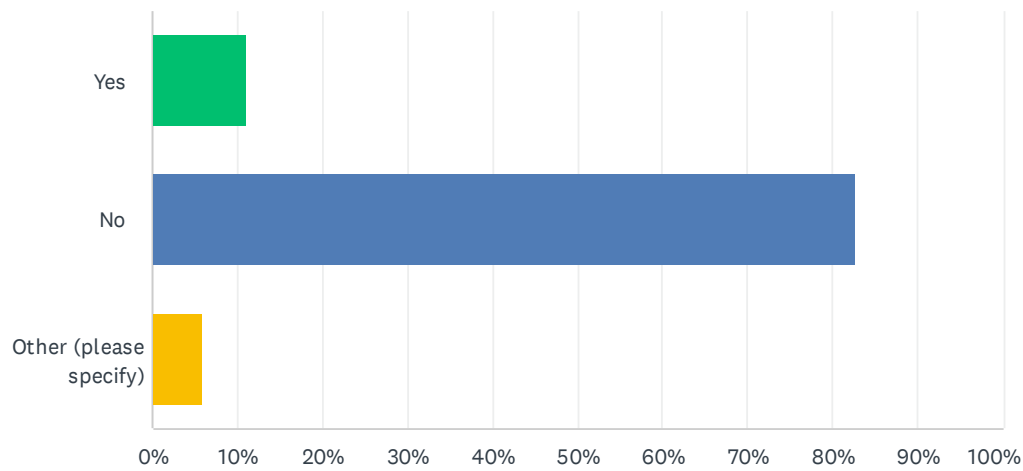

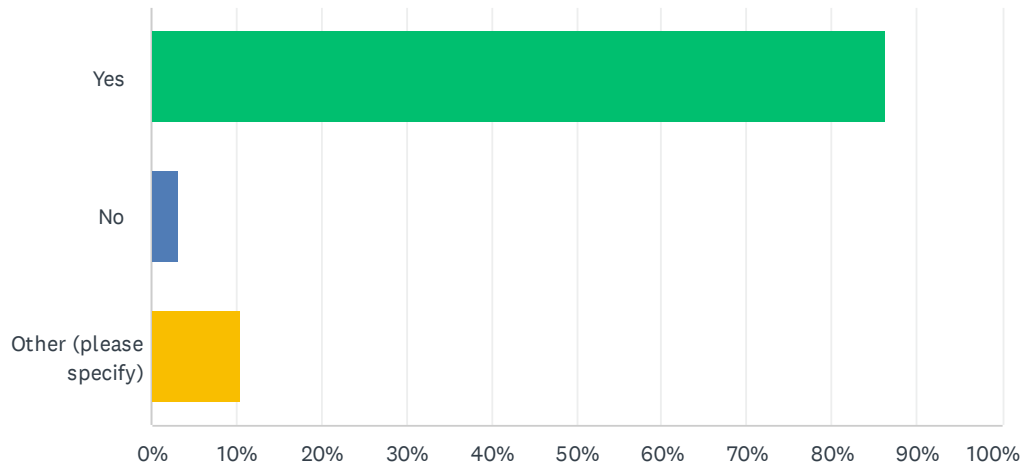

Q18 Do you agree that even minor development should incorporate water attenuation, storage and treatment arrangements?

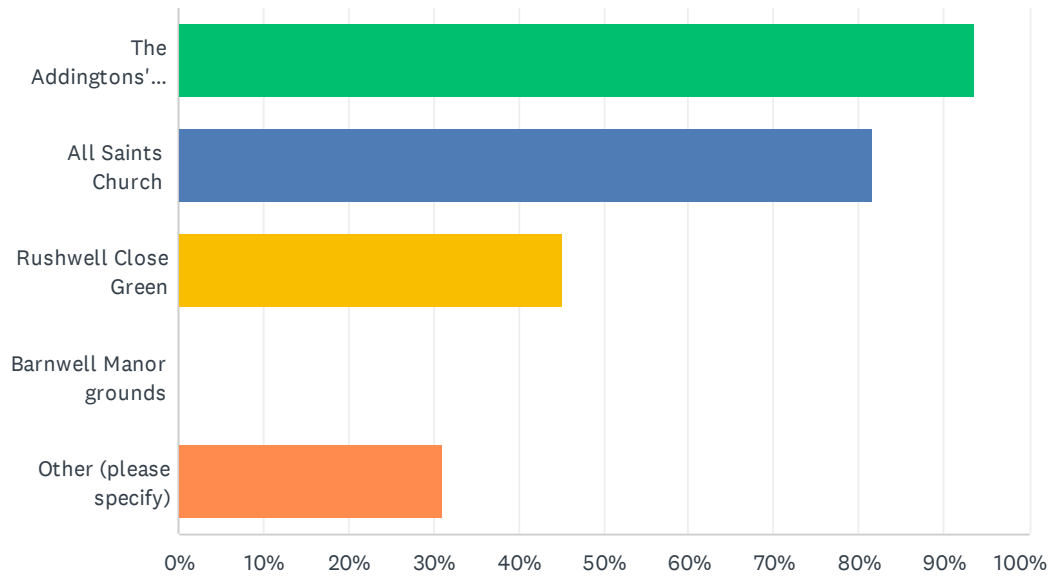

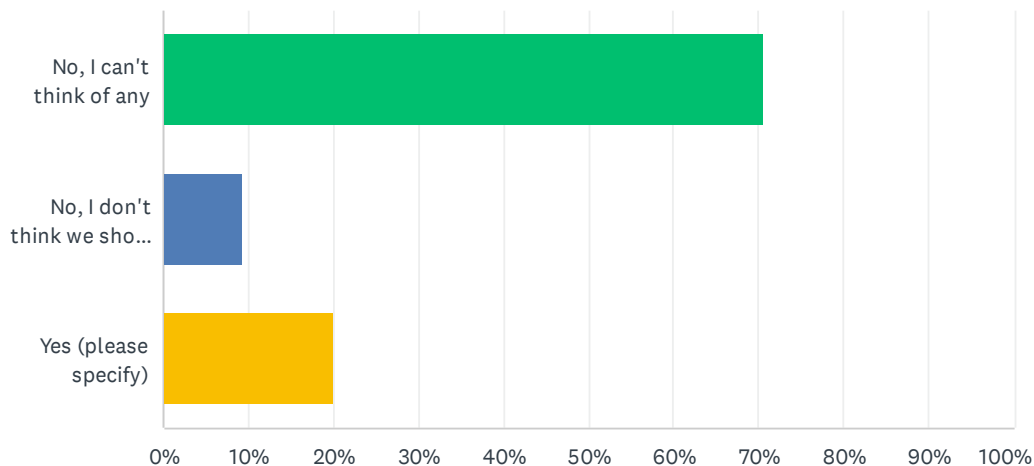

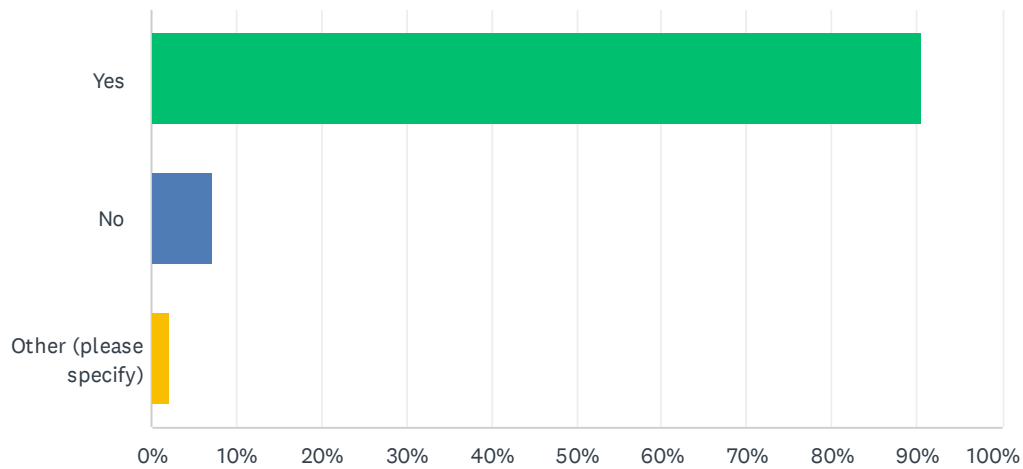

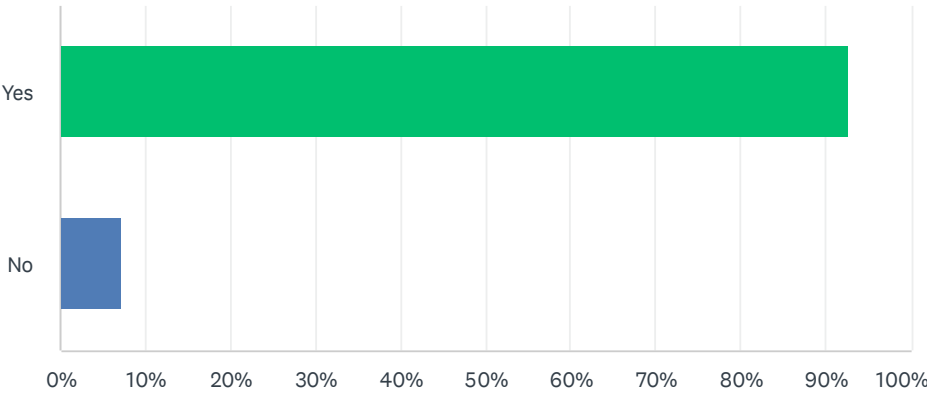

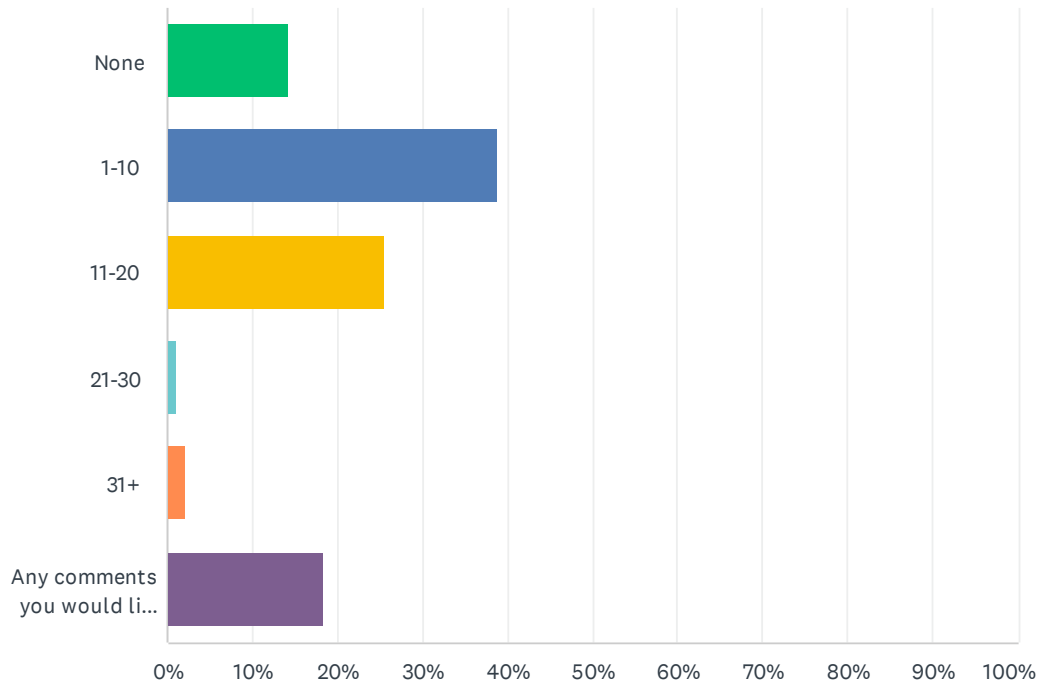

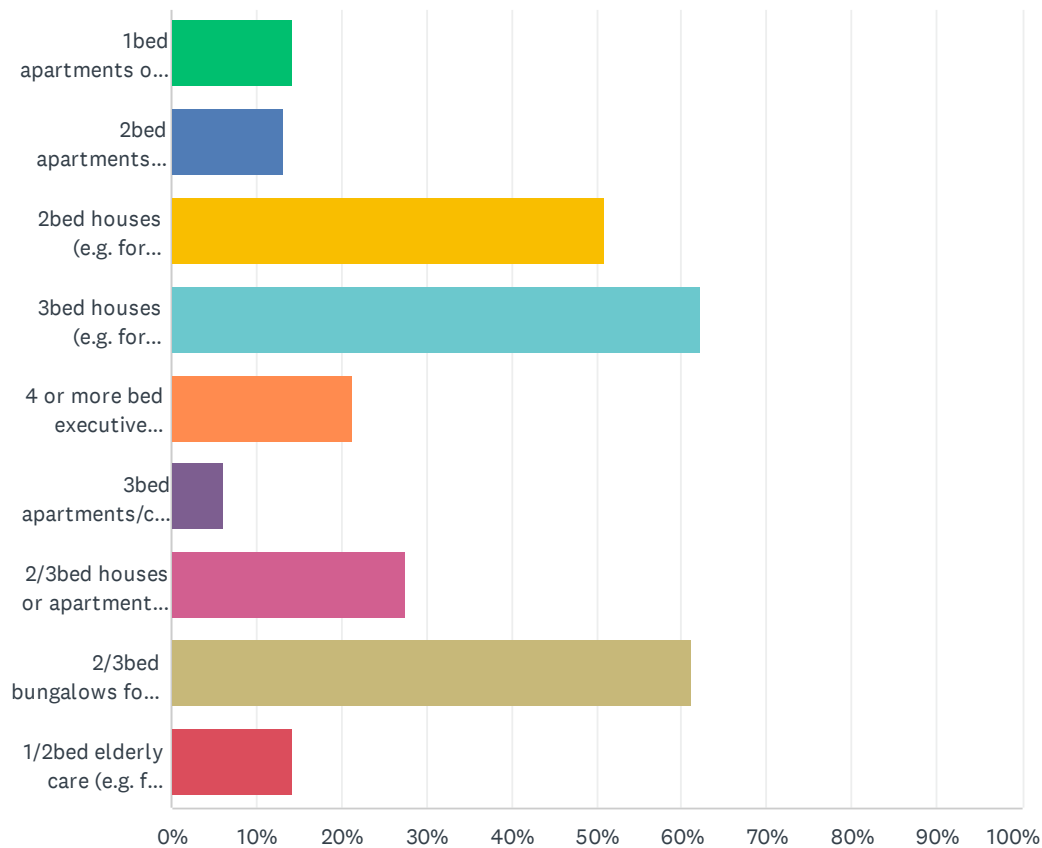

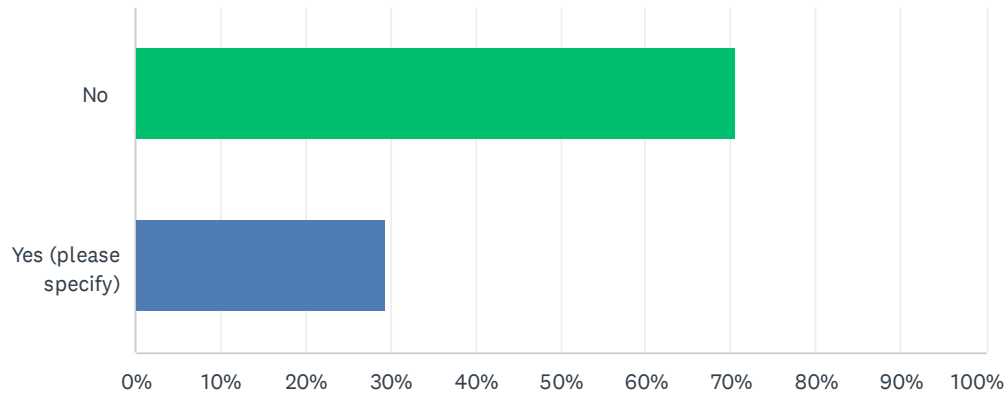

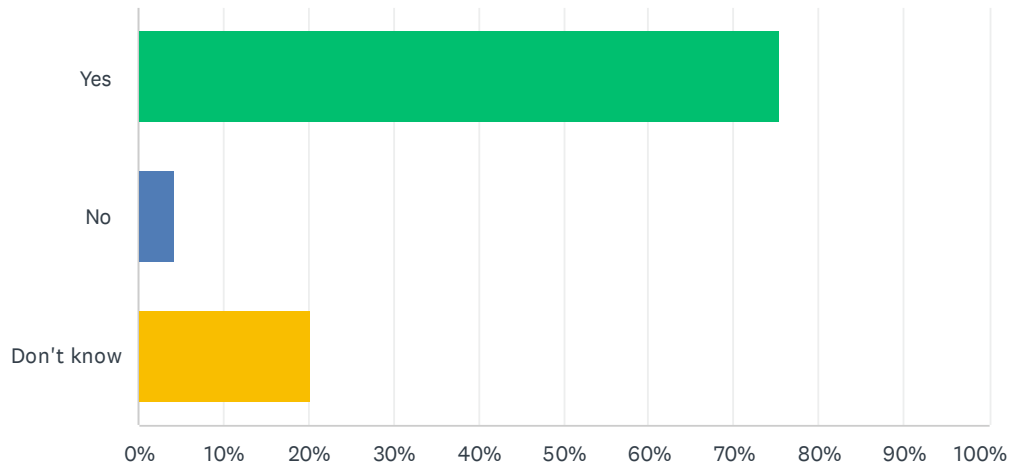

Q26 Do you agree that the definition of a Settlement Boundary is a good way of managing housing development?

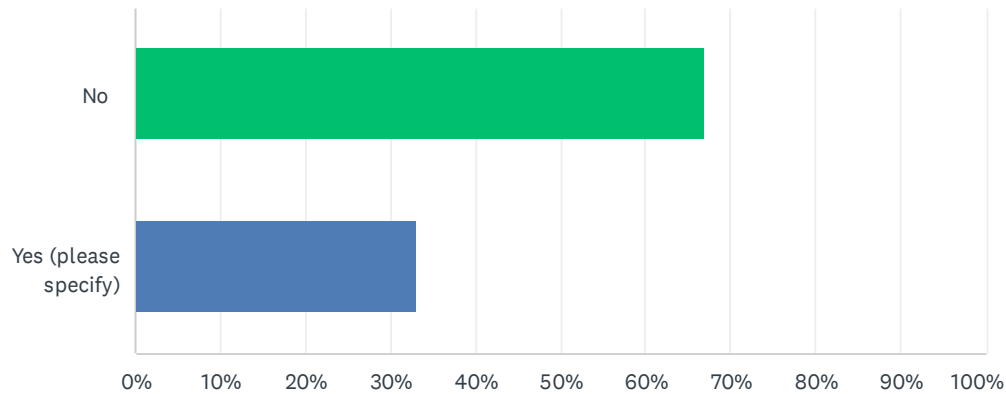

Q27 Are there any specific changes to the Great Addington Settlement Boundary shown below that you would like to see made in the Neighbourhood Plan?

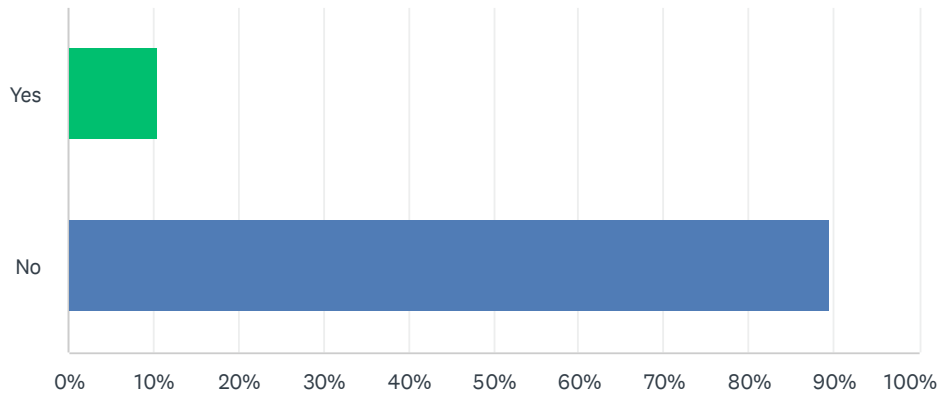

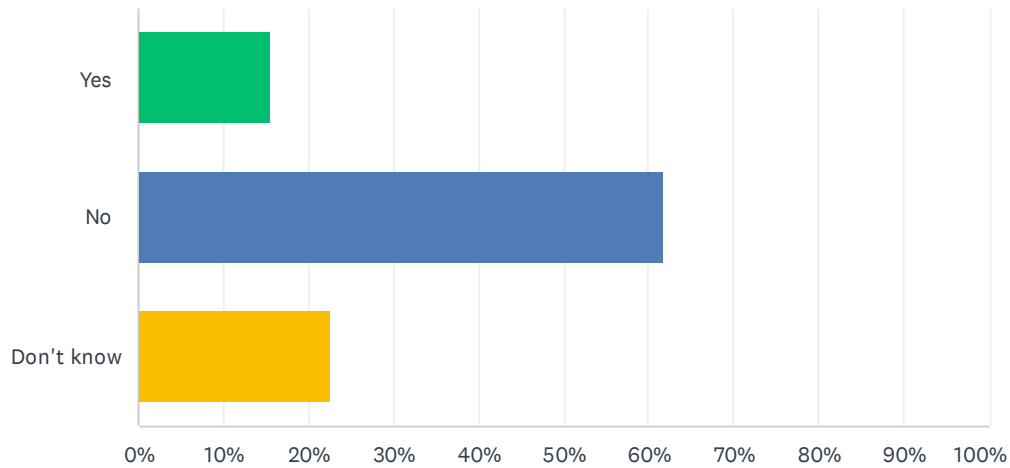

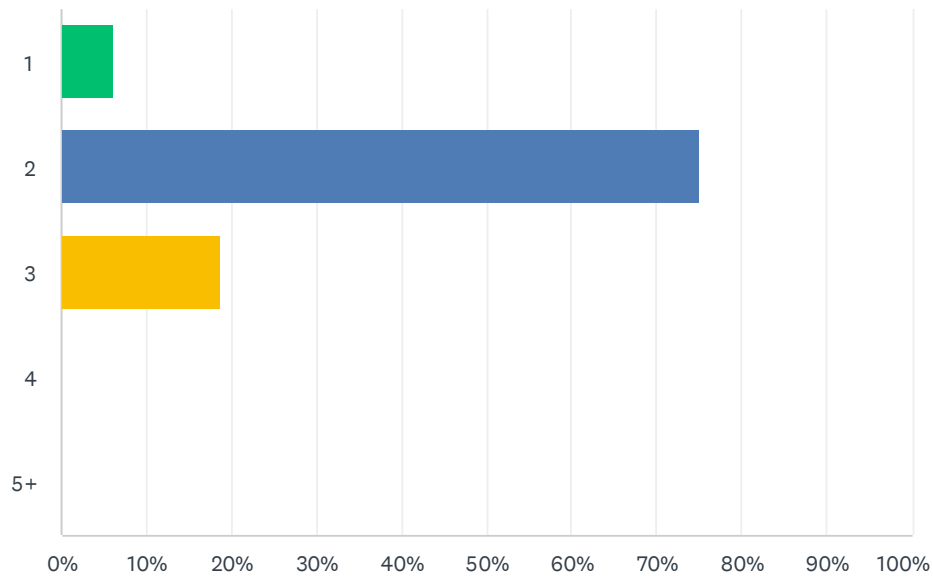

Q30 How many bedrooms would that household expect to need?

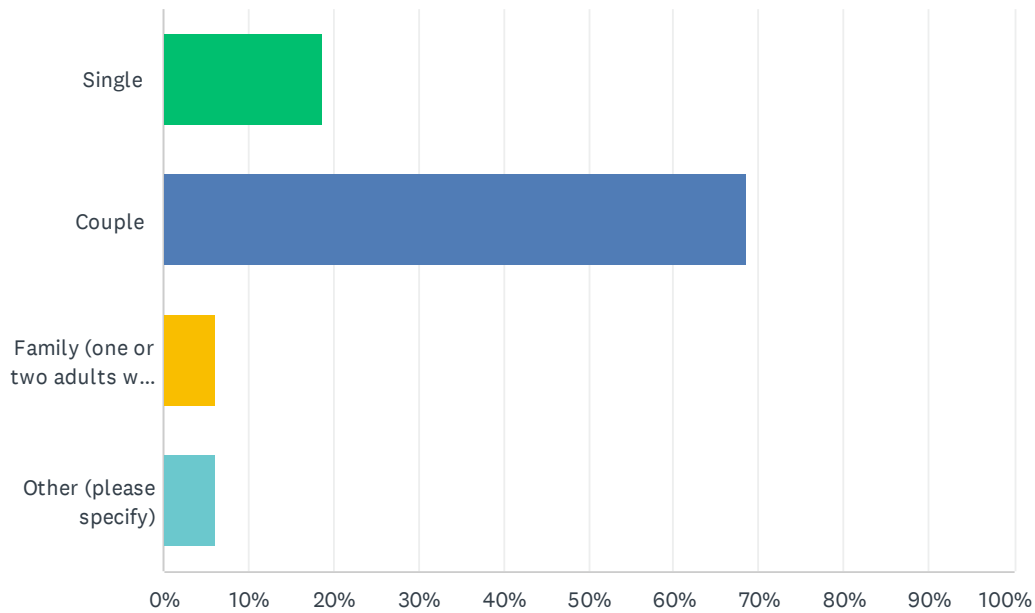

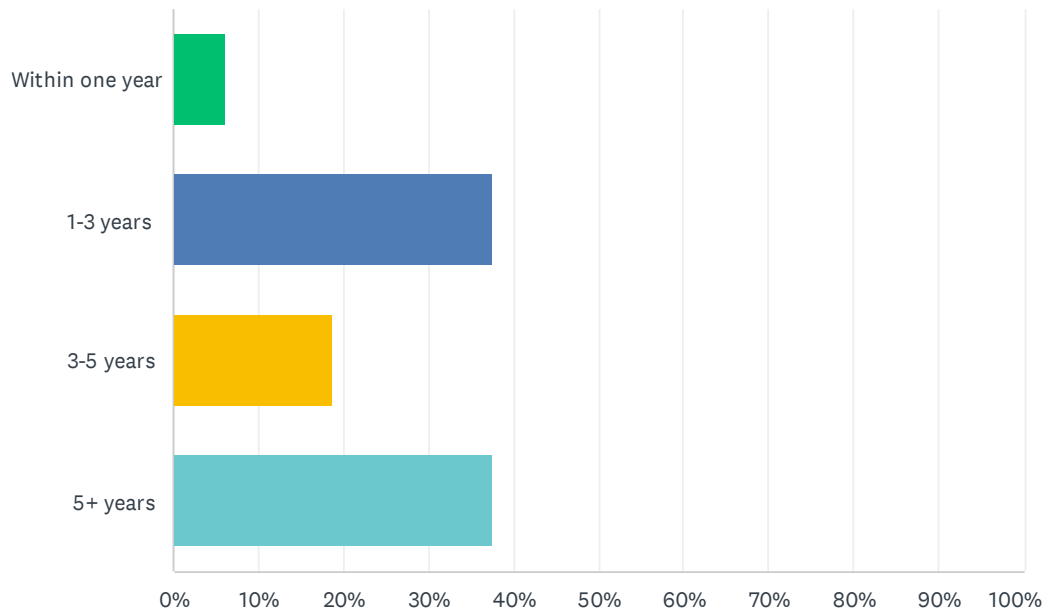

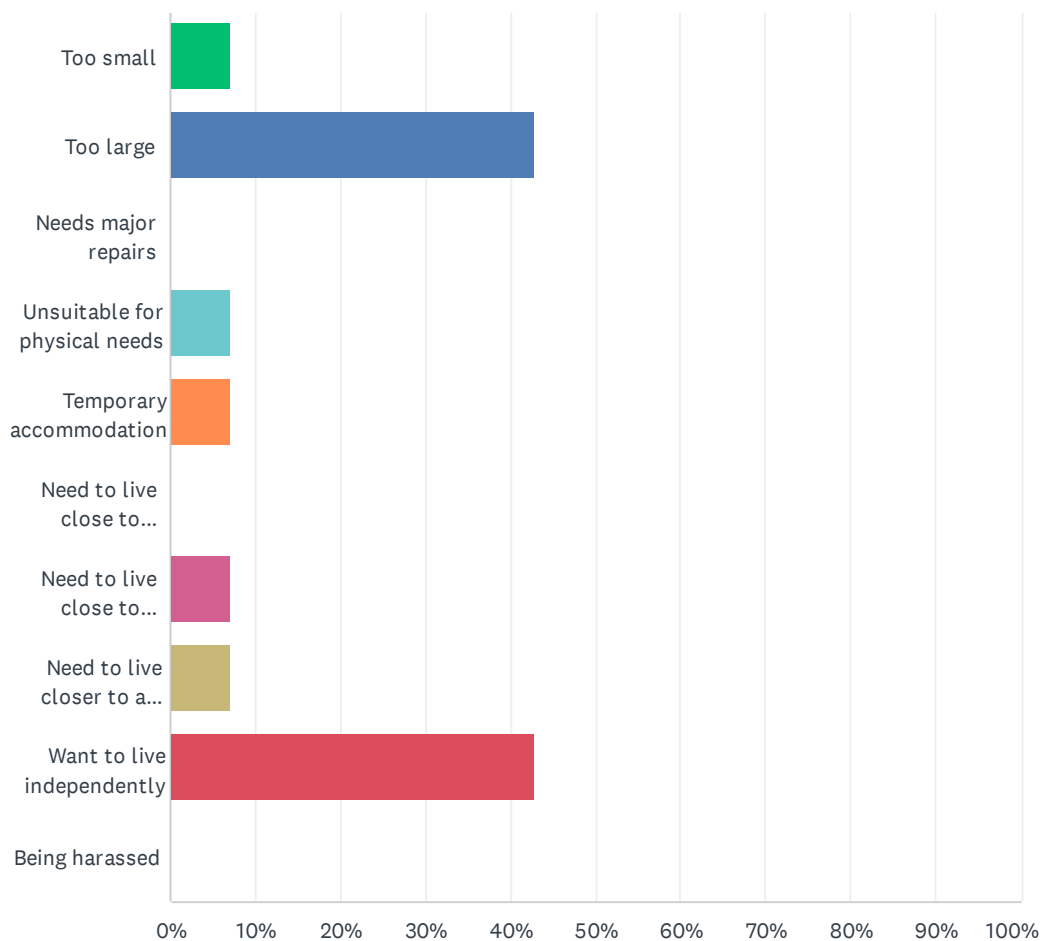

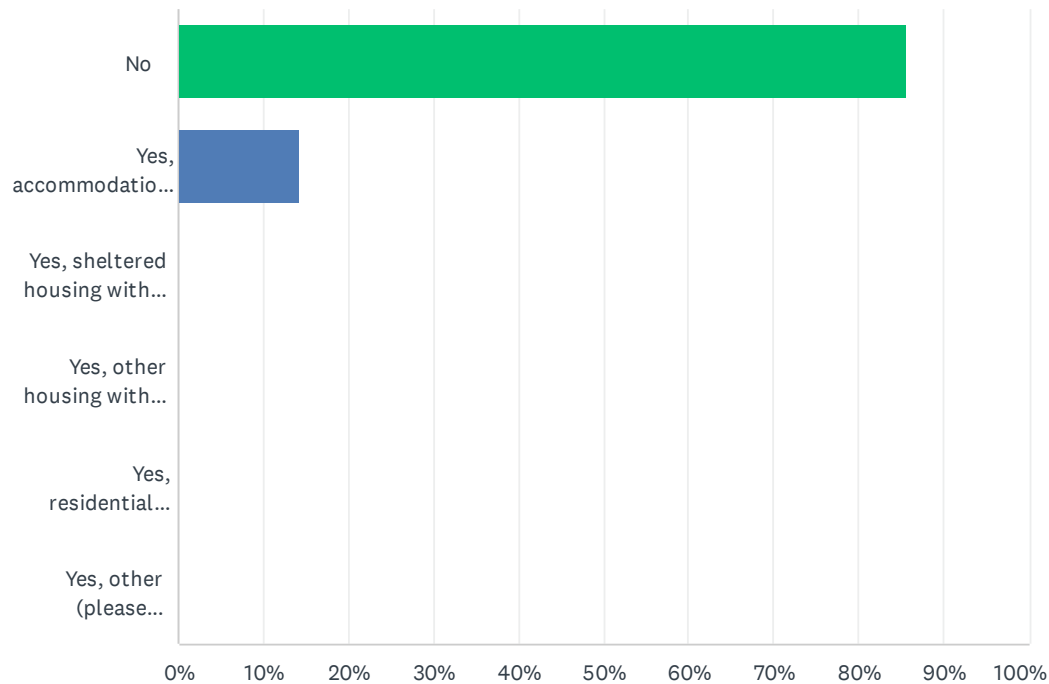

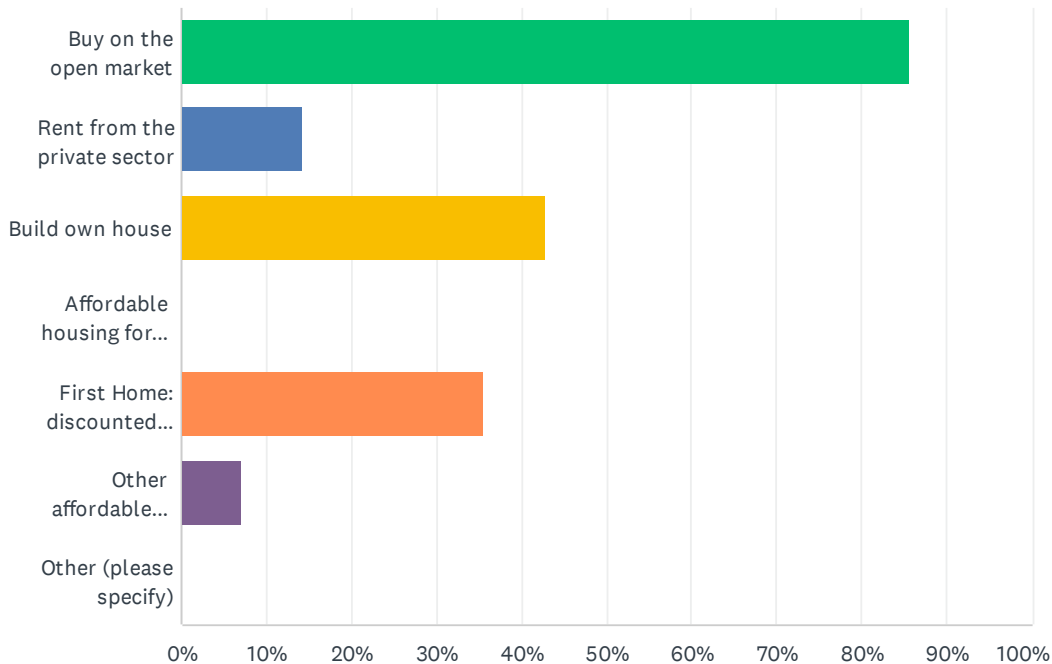

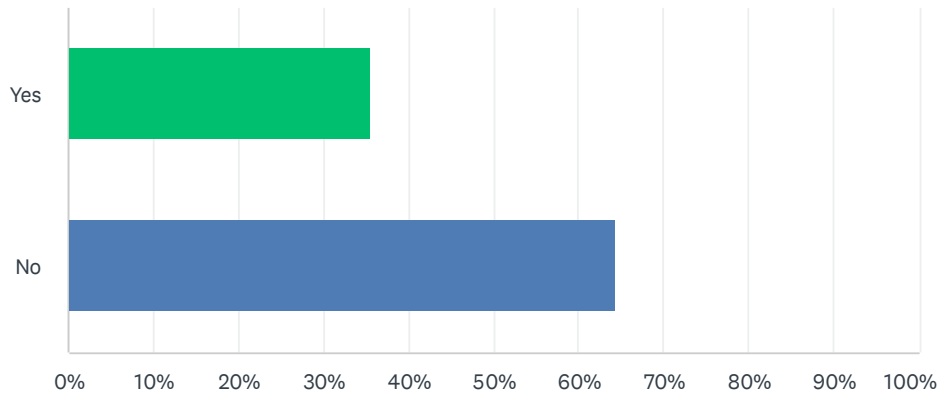

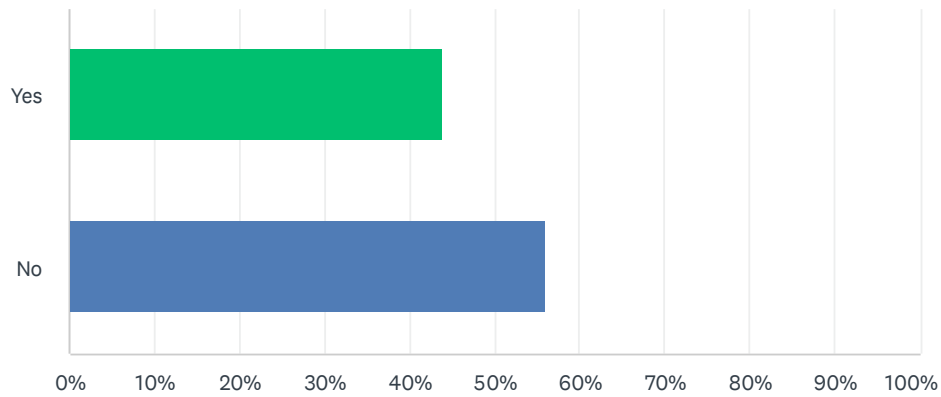

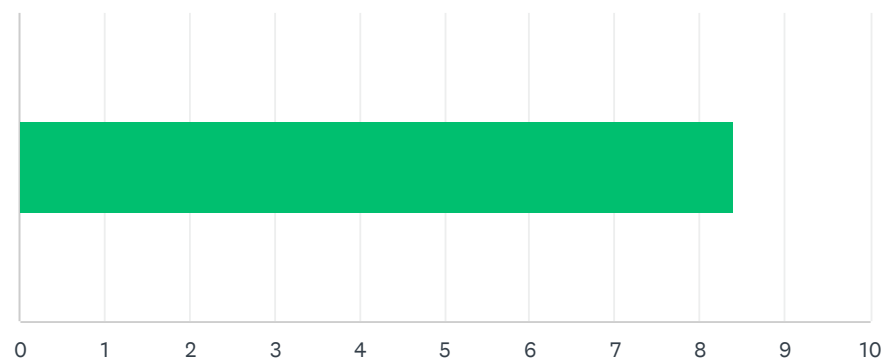

Q38 On a scale of 0 to 10, where 0 is not a problem, how concerned are you with speeding traffic through the village?

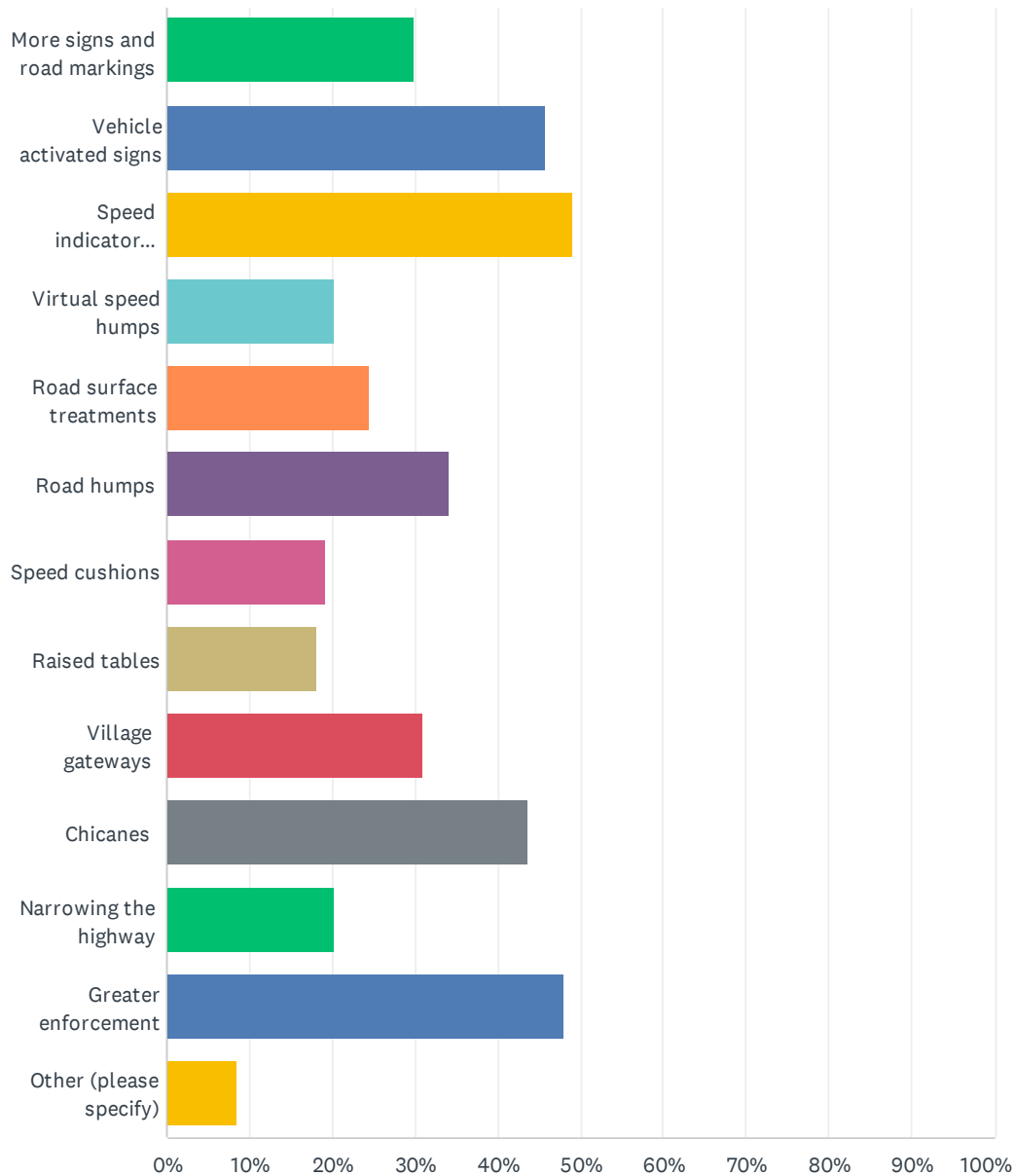

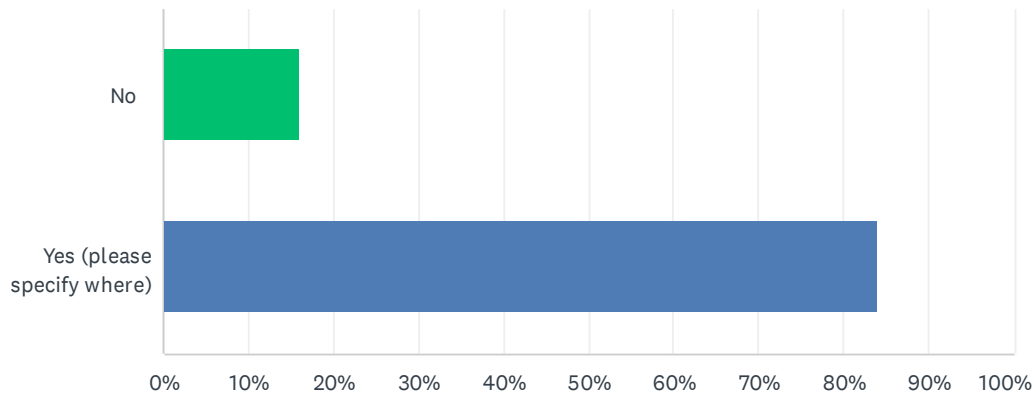

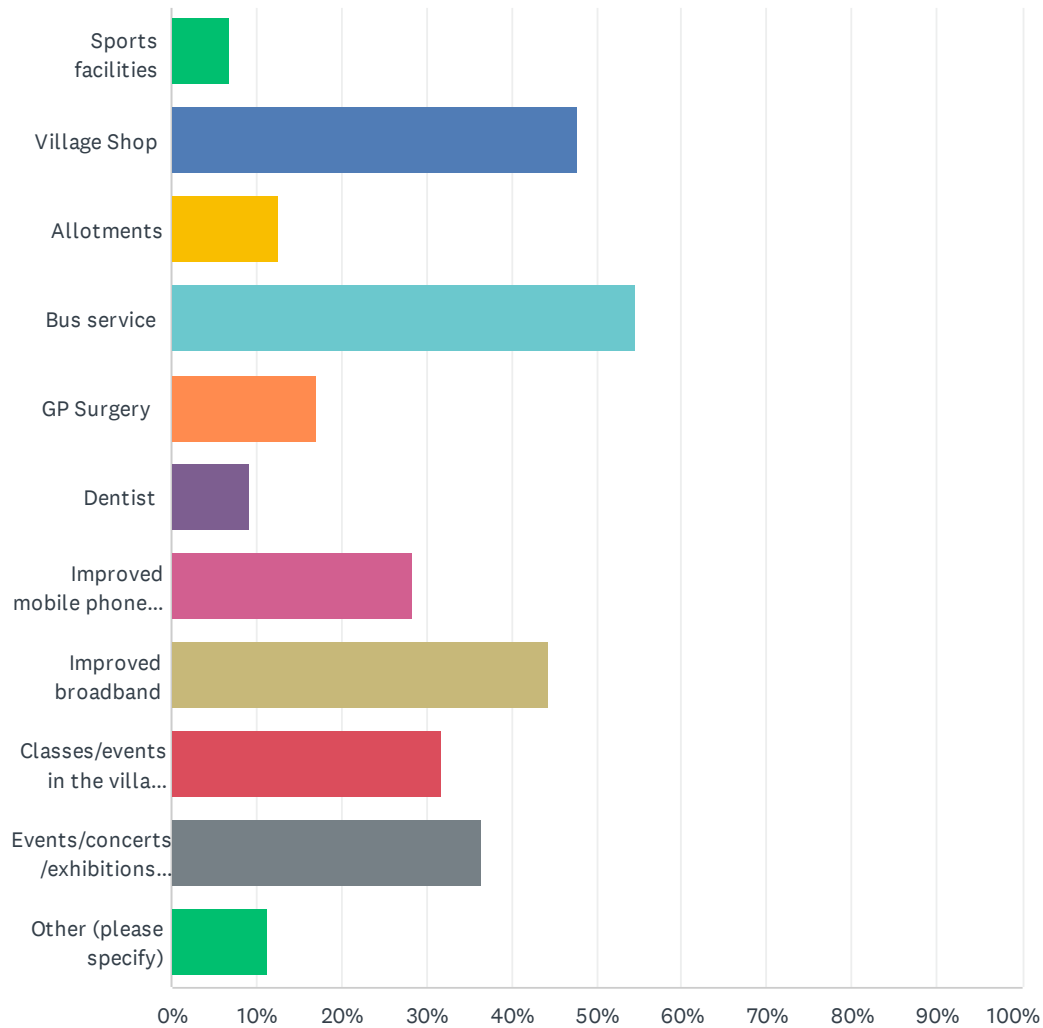

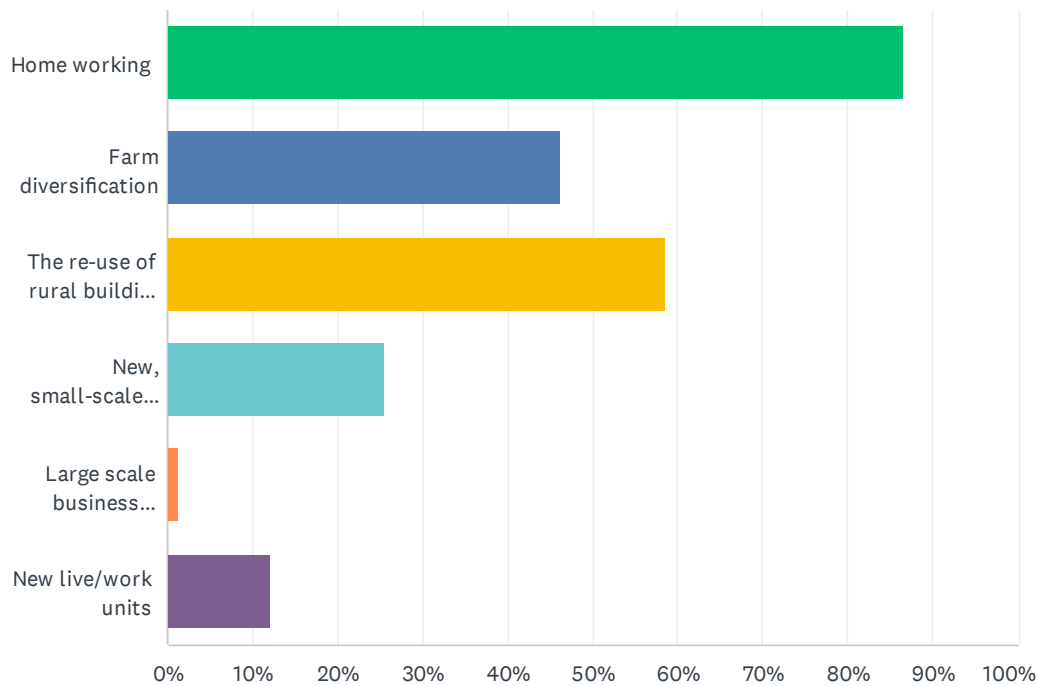

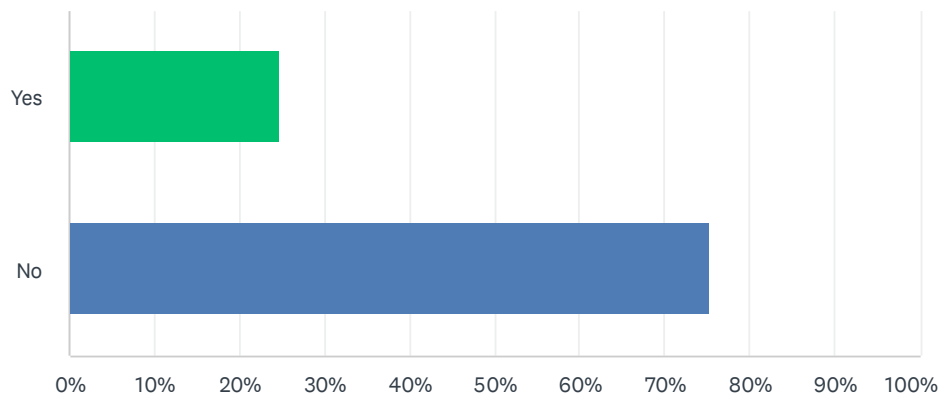

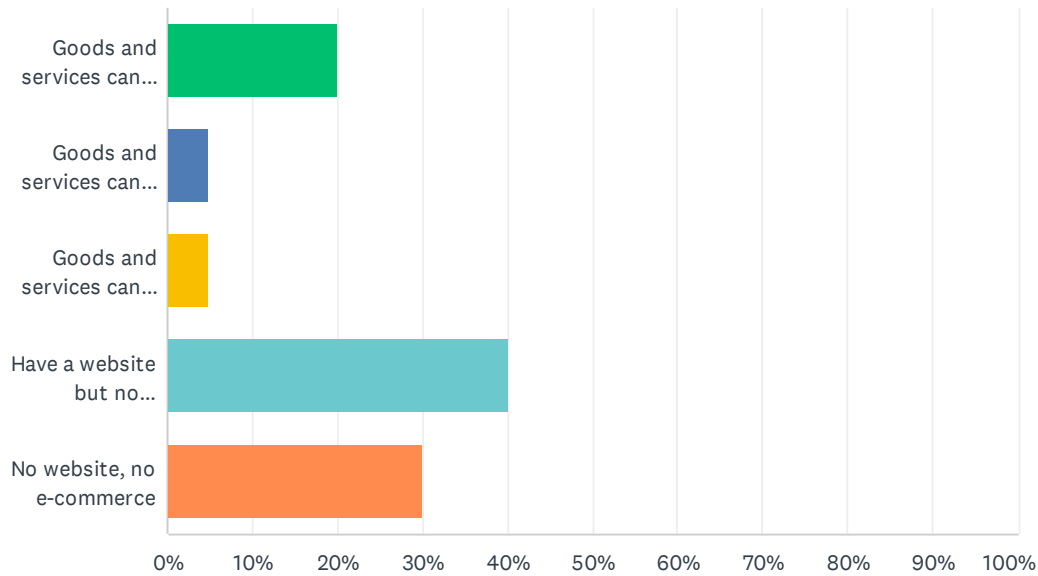

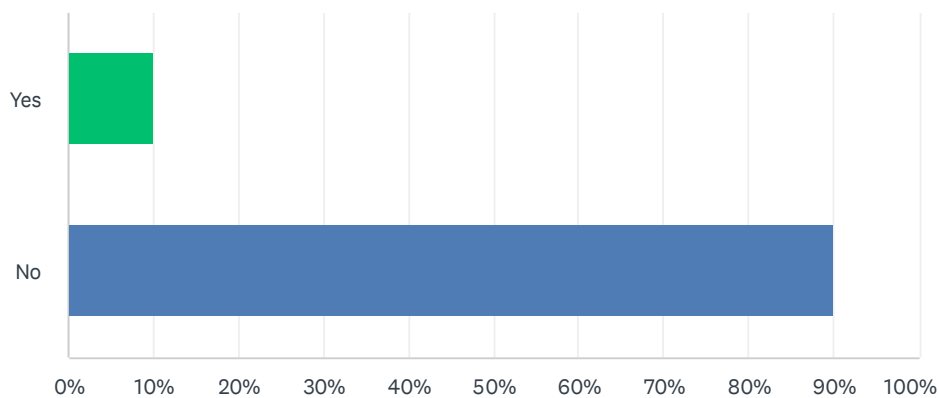

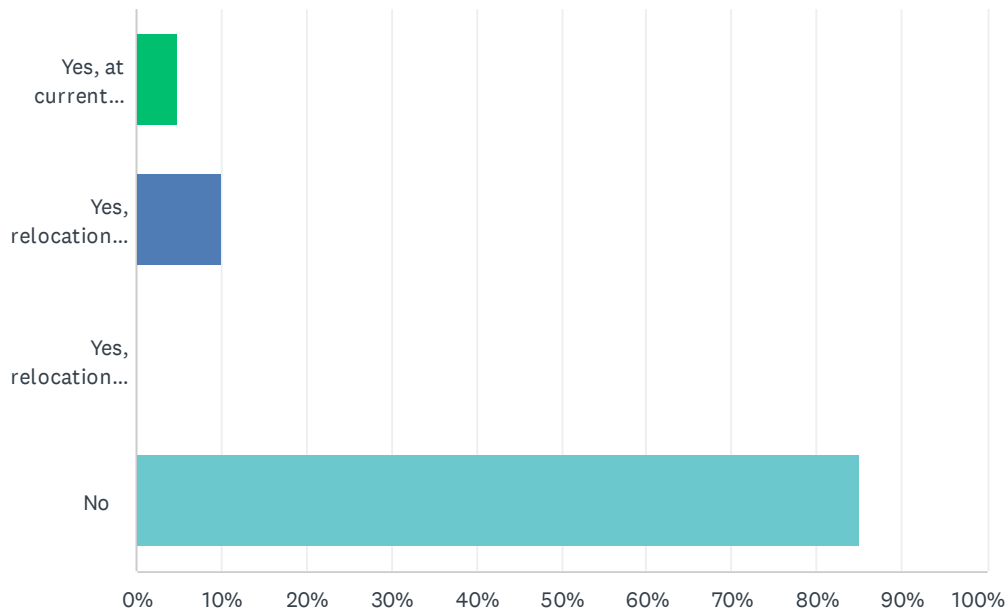

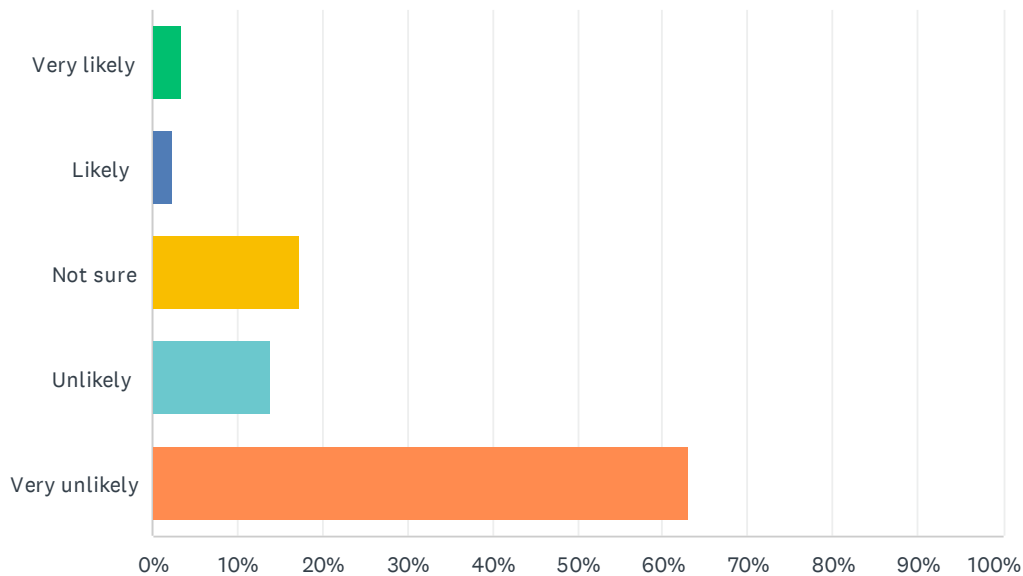

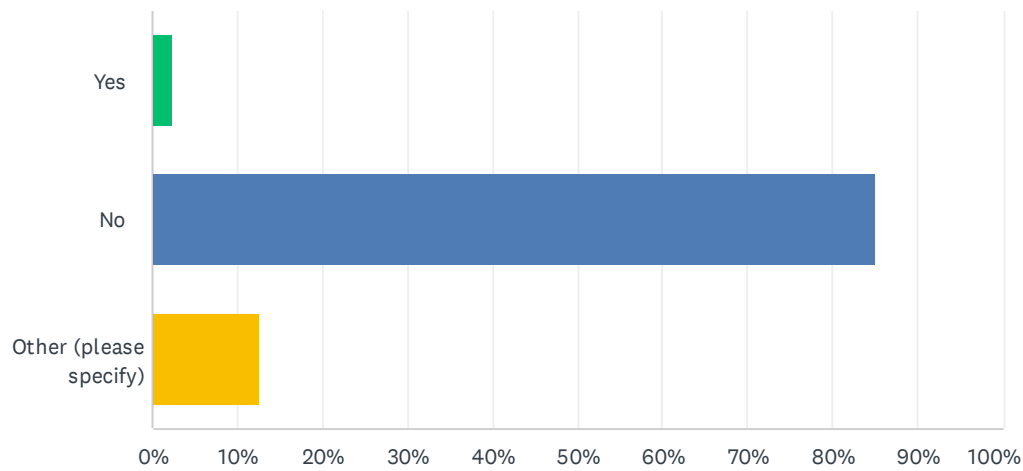

Q54 Do you support the proposed Kettering Energy Park?

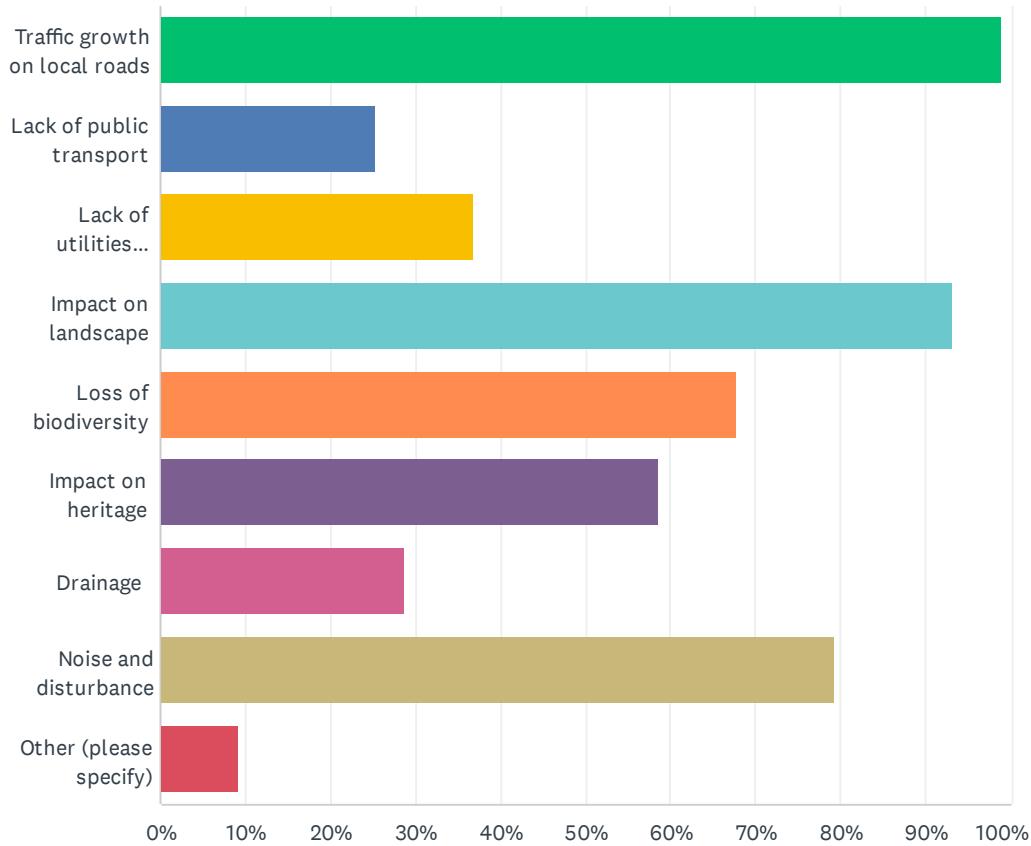

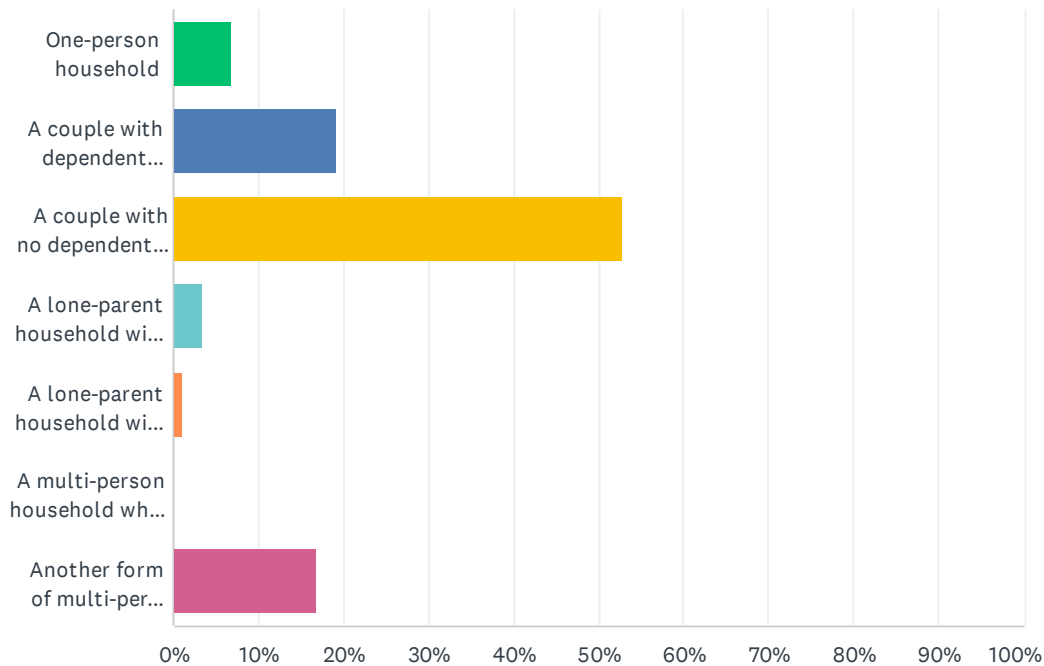

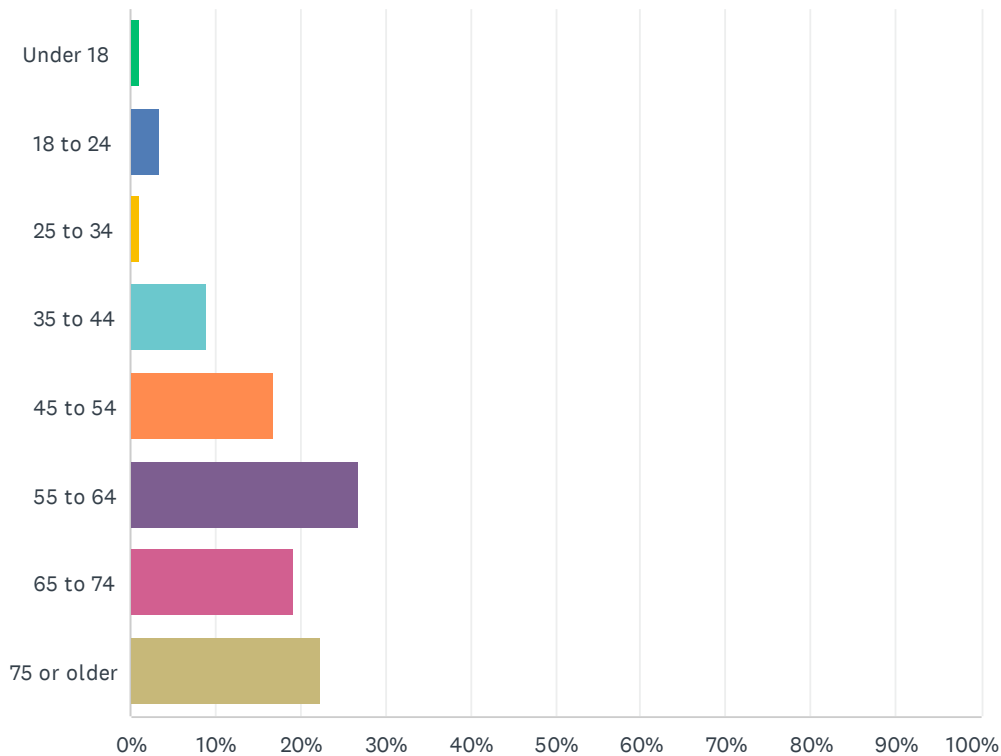

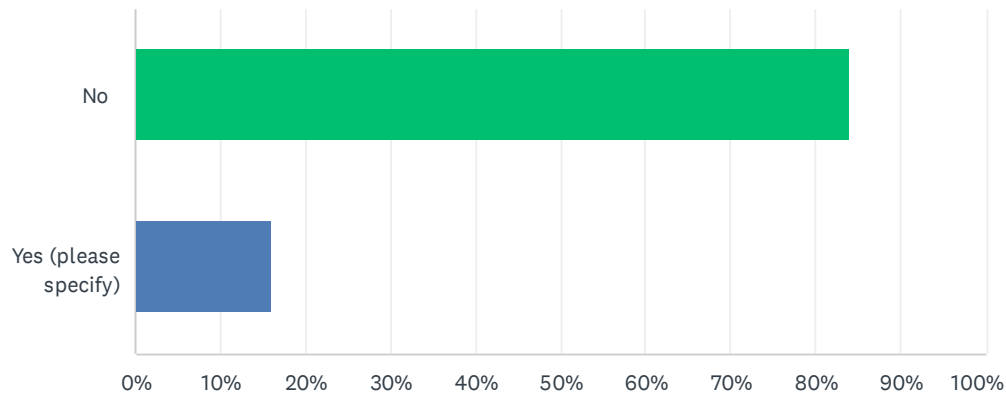
